We follow the Healthcare Effectiveness Data and Information Set (HEDIS®) measures from the National Committee for Quality Assurance for Controlling High Blood Pressure (CBP), which assesses:

- Proof of a blood pressure reading for members aged 18-85 who had a diagnosis of hypertension, and
- Proof that the patient's blood pressure is adequately controlled (less than 140/90 mm Hg) during the measurement year
