# Overview

- Agents must be certified each year to sell Gold Kidney Health Plan MAPD plans and be individually appointed by Gold Kidney Health Plan. Agents are also required to maintain active license status.
- Gold Kidney Health Plan utilizes EvolveNXT to deliver our annual onboarding and certification. We have designed a streamlined and simple process to get you certified and ready to sell.
- The program includes ensuring current agent information is on file, how you would like to be paid, license and appointment verification, background check, Medicare Certification and Errors & Omissions upload, and Gold Kidney product training and exam.
- You are allowed 4 attempts to pass the certification exam before you are locked out of the system.
- We are excited to get you onboarded with Gold Kidney Health Plan. Our priority is to make it easy for you and your downline to represent Gold Kidney Health Plan. Use this guide to help you get started.

# Getting Started

## New Users

New users can begin the onboarding/certification process by submitting a contracting request. You may submit a request 3 different ways:

- Submit a contracting request form via the Gold Kidney Health Plan website ([click here](#)).
- Send an email to [contracting@goldkidney.com](mailto:contracting@goldkidney.com) with your name, NPN, email address and upline name (if applicable).
- Submit a request to your upline. Your upline can create a contracting case on your behalf.

## Existing Users (Recertifying for 2026)

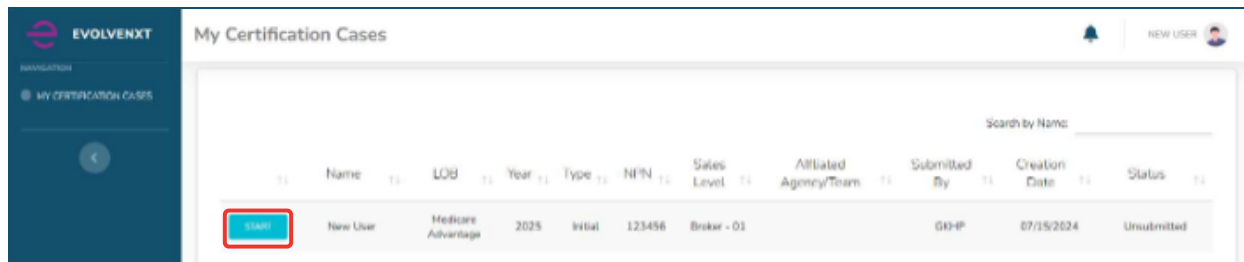
Existing users will receive a recertification email with instructions to access the Certification Case in EvolveNXT (Subject: Gold Kidney 2026 Recertification and Training).



# Accessing your Certification Case

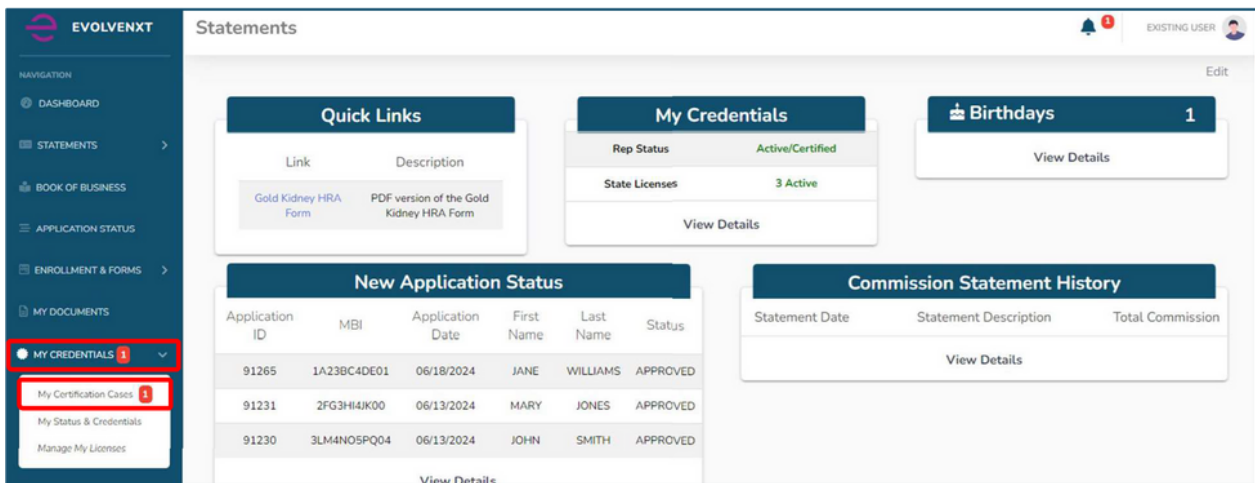
## New Users

Agents who are new to Gold Kidney Health Plan will need to complete an Initial Certification case. Upon logging into EvolveNXT, you will be on the My Certification Cases page.

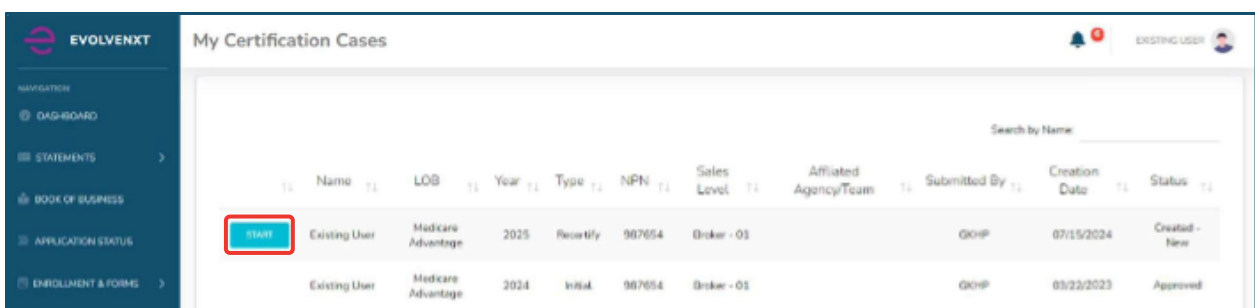


## Existing Users (Recertifying for 2026)

Existing users will complete a Recertification case. Upon logging into EvolveNXT, you will be on the **Dashboard**. To access the recertification case, click on **MY CREDENTIALS** in the navigation panel to the left (2) then select **My Certification Cases** (1).



The **My Certification Cases** page will open. Click **START** to begin your 2026 certification.

| Training        | <ul style="list-style-type: none"><li>• All agents must review and complete the 2026 GKHP Medicare Certification Training and pass the 2026 Certification Exam. <i>Please note: You may download a copy of the training by clicking 'DOWNLOAD TRAINING MATERIAL'</i></li><li>• You must receive a score of 85% or higher to pass.</li><li>• You are allowed 4 attempts to pass the certification exam before you are locked out of the system.</li><li>• Once your status shows Passed, you will be able to move forward.</li><li>• Click <b>Continue</b> to proceed.</li></ul> |
| Submit          | <ul style="list-style-type: none"><li>• The final step will present you with our Gold Kidney Producer Contract and your W9. W9 is populated from the information that was entered on the Payment Tab (if applicable).</li><li>• You can open and read both documents by clicking on them.</li><li>• You will then check the boxes and sign your name in the space provided.</li><li>• Click <b>Submit</b>.</li></ul>                                                                                                                                                            |

# Next Steps

## All Users

Once submitted, you will see a **“Submission Successful”** screen. You can download copies of both your contract and W9 (if applicable) on this screen.

Your case has been submitted to the Gold Kidney Health Plan staff for review and background check processing. Please allow 3 - 4 business days for review.

Once, accepted you will receive a confirmation email letting you know you are ready to sell Gold Kidney Health Plan for both 2025 and 2026 plan years.
